Order forms for both Reach for the Stars and Advanced Badges and Stars Awards may be found by going to alabamamg.org, looking under "AMGA Publications and Forms," and clicking on "AMGA Forms." Select and print the forms needed. Instructions are on the forms. Checks should be made out to AMGA and submitted to the Reach for the Stars Chair with the order form. Please do not send checks to the AMGA Treasurer.

Information and instructions for the other award nominations are found on the same website, alabamamg.org, again under "AMGA Publications and Forms." To see the requirements for submission, select "AMGA Awards and Criteria." Each award is listed

separately with its unique instructions. Please follow those instructions.

A change in the Outstanding Newsletter Award was instituted last year. There are three categories: 1) Associations with up to thirty-two (32) AMGA members, 2) associations with thirty-three (33) to fifty-nine (59) AMGA members, and 3) Sixty (60) and above AMGA members. All associations are encouraged to make submissions in the appropriate category. If your association has previously won this award, you must wait three years before your next submission. Newsletters to be judged will be May and October.

One important note to remember – all nominees for AMGA awards, except for the Gary Murray Outstanding Service Award honoring Non-Master Gardeners, must be current AMGA members in good standing.

## AMGA PROJECT FUNDING

As of November 29, 2018, the Project Funding committee has received no applications for grants. The deadline for submission of applications is January 15, 2019, which leaves plenty of time for applications to be completed and submitted. to the tab AMGA Publications and Forms (right side of the page), click on Forms, and then Project Funding Grant Application. An Association may receive funding for only one approved project within a three-year period.

In 2018, Autauga County was awarded \$1,775, Cherokee County \$1,000, and Chilton County \$2,500 for a total of \$5,275. A total of \$7,500 is available for 2019. Please do not leave this money sitting on the table!

#### **AMGA TREASURER**

As we approach the end of 2018, your association is in a strong financial position. AMGA's fund balances on deposit at Regions bank exceed \$105,000, and we have no outstanding liabilities at this time.

Funds provided by local MGAs have enabled AMGA to contribute, on their behalf, over \$7,500 to the Auburn Graduate Endowment Fund.

Starting in 2019 the "books" of AMGA will be moved to QuickBooks Online. There are several reasons for this, the primary being that the treasurer and assistant treasurer must be able to access the accounts. That simply cannot be accomplished if the records are stored on a single computer as they exist now. Additionally, during the conversion process, the accounts of AMGA will be streamlined and simplified

for better reporting relative to budgeting going forward.

Like AMGA, many County Master Gardener Associations' bylaws require, or certainly should require, an annual review of the treasury activities or an "audit." The analysis is most useful if done by someone outside of the local organization. I encourage all county chapters to have an annual review performed. A question that has arisen recently is "should the treasurers be bonded?" I would encourage each association to at least visit this question and make a sound business

decision regarding this issue.



## From The State MG Program Coordinator





Washington State University Cooperative Extension started the MG Program in 1971 with this purpose – foster a crew of Extension ambassadors who would expand their educational programs. Since then Extension in other states adopted the program for this same reason. Then and now, we need your help.

Last year, Alabama MG volunteers made 2.5 M public contacts through educational outreach. That was 2.5M opportunities to promote our "Extension" partnership and a huge brag point to an Extension Administrator. Did we remember to say it? Every time you mention our Extension-MG partnership, you raise the value of our program. Don't take this for granted.

The point? I shouldn't make any assumptions. Do you see yourself as an Extension ambassador?

It's an easy assumption – We expect that something of value will remain constant.
